The new radio system testing has begun, will be in town here next Tuesday checking our area.

We applied for an IDNR grant to replace Wildland gear that we got in 2012, out of date now. Trying to get ten sets at a cost of \$9420, this is a 50/50 match.

Safer Grant is over this November. Working with the grant guy on a new one for another 4 years. Grant just opened this week.

AFG grant for radio's, bill for GTSI is here. Part of this is grant and part will be us.

The annual fire extinguisher check by AEC was completed today, two went in for service. We will also be buying two small extinguisher for the cabs of brush and tanker.

OSFM did a visit with us here last Friday, new contact for our area. He also went over what OSHA inspectors have been doing when visiting other departments. He went over some new policies they are looking at and items they are looking at around the station. From gear, cleaning procedure, to all flammable need to be in flammable cabinet that are not on the vehicles, auto eject cords not touching the ground, Air Compressor test certificate posted on the compressor, etc., plus the ones we already have and do.

Have an individual from town, been here over a year is a retired deputy and former FF from Elkhart in the seventies. He wanted to help us out. I said we have been looking for just this for some that would be around that can drive big trucks and pump. I gave him all the info and which on-line courses he needs to do; the driver and pump operator training will be here. This will be a new classification as Driver/Engineer. Roger Stewart
